AMENDMENT TO BY-LAWS

OF

THE ISLAND AT HIDDEN HARBOUR (A CONDOMINIUM)

THIS AMENDMENT TO CONDOMINIUM BY-LAWS, made this day of February 2006, by the Council of Unit Owners of The Island at Hidden Harbour (A Condominium) ("The Island at Hidden Harbour"), WITNESSTH:

WHEREAS, The Island at Hidden Harbour was established by the Condominium Declaration and By-Laws, made by Hidden Harbour VI, Inc., dated June 7, 1993, and recorded among the Land Records of Worcester County, Maryland, in Liber R.H.O. 1939, folio 259, et seq., and pursuant to the several Plats described in said Condominium Declaration and By-Laws, which said Plats are recorded among the aforesaid Land Records in Plat Book R.H.O. 135, folio 69, et seq.;

WHEREAS, The Council of Unit Owners wishes to further amend Article IV, Section 2 of the Condominium's By-Laws so that the annual meeting is not required to be held on the second Saturday in September;

WHEREFORE, the Council of Unit Owners of The Island at Hidden Harbour hereby amends Article IV, Section 2 of the aforementioned By-Laws to state as follows:

Article IV, Section 2. Annual Meetings. The annual meeting of the Council shall be held in the month of September, or at such other time as the Board of Directors shall determine, but, in any event, not later than as may be required by statute. At such meeting there shall be elected by ballot of the Unit Owners a Board of Directors, in accordance with requirements of Section 4 of Article V of these By-Laws. The Council may also transact such other business of the condominium as may properly come before it. Failure to hold an annual meeting at the designated time, however, shall not invalidate the Council's existence or effect its otherwise valid acts.
